Community Cohesion Challenges: Traditional community structures face significant disruption in urban environments. High population density paradoxically creates social distance, as individuals develop coping mechanisms that

limit deep social engagement. The anonymity that cities provide can be both liberating and isolating simultaneously. **Technological Mediation:** Urban social relationships increasingly rely on digital platforms and technological mediation. While technology can maintain distant relationships and create new connection opportunities, it may also contribute to the superficialization of social interactions observed in urban contexts.
